The 2011-13 biennial budget was Gov. Scott Walker's first, and the 2017-19 budget his last. Both of those columns show final figures. The 2019-21 column is Gov. Tony Evers' first biennial budget. At this time, it displays his budget recommendations, as the document has not yet been signed into law.
